It shall be provided in width; six (6) inch wide, Eighteen (18) inch on center. (intervals center to center when measured perpendicular to the stripe). This striping shall slope downward to street-side (driver's side of vehicle) of the vehicle at a forty-five degree (45°) angle from horizontal. This spacing location (relative to overall surface being striped) shall provide the maximum number of full width blue stripes across the rear of vehicle. (Diagram provided upon request)
